

BYLAWS OF THE SOCIETY.

- 1) The name of the Society shall be 'Sri Sankara Ramana Kendram'.
- 2) The Registered Office of the Kendram shall be in Maharajanagar, The Registered Office shall now be located at B-81, Maharajanagar, Palayamkottai.
- 3) The Kendram was initially formed on 21st April, 1978.
- 4) The registered office of the society is now within the jurisdiction of District Registrar, Palayamkottai.
- 5) The business hours of the Kendram will be from 8.30 a.m. to 12.30 p.m. on all working days.
- 6) The objects and aims of the Kendram shall be as follows:
  - or
  - i) To start, manage and/to take over educational institutions, hospitals and allied organisations etc. and any other charitable organisations.
  - ii) To award scholarships and fellowships for promotion of higher education.
  - iii) To promote on cultural and religious activities.
  - iv) To accept gifts of property movable and immovable and moneys from donors on such terms and conditions as may be agreed to between the donor or donors and the governing body of the kendram but so as not to incur any personal liability on the part of the members of the Governing Body.
  - v) To obtain grants of gifts of lands and buildings or other property, movables and immovables and moneys by way of Block grants, recurring grants, maintenance grants and stipendiary grants from the Union Government or any of the State Governments or from any Quasi Government Corporations or bodies or from any Municipal and local bodies on such terms and as may be acceptable to the Governing Body.
  - vi) To acquire by purchase or lease immovable property to carryout the object of the Kendra.
  - vii) To obtain by lease or other arrangement, possession and use of land and building from any person, body or Government of a State or Government of the Union of India on such terms as may appear reasonable to the Governing Body.
  - viii) To invest surplus moneys belonging to the Kendra as decided by the President, Secretary and the Treasurer.
  - ix) To collect and maintain a fund to be contributed by voluntary donation and by subscription for carrying out the objects and purposes of the Kendra.
  - x) To promote rural industries in villages for welfare of villagers.
  - xi) To carryout the objects of the Kendra without any motive for profit, the aim being provision of educational facilities and medical relief to the general public and the residents of Maharajanagar in particular.

- xii) Finally to do such other lawful note and things as may be necessary or incidental and conducive to the attainment of the above objects of the Kendra.
- 6) A. The Society in furtherance of its objective shall start schools, hospitals etc and the Board of Trustees may time to time draw plans to have activities in furtherance of its objects.
- 7) The Qualification for membership of the Kendram, the person should be 21 years of age and above and who subscribes to the objects of the Society and contribute Rs.1,000/- towards membership fees at the time of joining, subject to the approval of the President and he may reject any application for admianion without assigning anyreason. The President may waive the contribution of Rs.1,000/- at his discretion.
- 8) The Kendram shall sue and be sued in the name of the ~~Socie~~ Secretary of the Board of Trustees or in the name of the person generally or specifical-ly empowered in this behalf by the Board.
- 9) The members of the committee shall hold office for a period of one year. The President can remove any member from the Management Committee without assigning any reason.
- 10) The administration and Management of the Kendra shall vest in and be conducted by a Board of Trustees under the President hereinafter called as the Board forming the Governing Body of Managing Committee of the Kendra, consisting of 7 members.
- 11) a. The Trustees constituting the Board shall not be less than seven and not more than fifteen.
- 12) The President is emp/owered to give directions regard- ing the business of the Society and he will preside over all the meetings.
- 13) The strength of the Board may be increased from time to time as the President may decide. There shall be three categories of Trustees:-  
1) Ex.officio  
ii) Donor and  
iii) Nominated.
- 14) The President may from time to time nominate other Trustees in addition to the above for the period to be specified.
- 15) Any casual vacancy arising among the Trustees either by resignation or otherwise shall be nominated by the President.
- 16) Notwithstanding any vacancy in the Board, the remain- ing trustees shall function as the full board of Trus- tees and any actor resolution effected by them shall be valid as that of the full Board of Trustees.
- 17) a. Mr. VSV Mani shall be the life President of the Board of Trustees and Miss V. Aruna, Ms. M. Ponnuswamy Iyer, N. Narayanan will be the life members of the Board





- of Trustees. Other trustees will hold office for a period of one year. They will be in the Managing Committee.
- b) In the case of sudden death or physical incapacity of the President the life members can elect among themselves a President. The President must be from life members and the incumbent should be Hindu.
- 18) The Board shall have power to appoint any committee or committees for carrying out the objects of the Trust.
- 19) The funds of the Society and all the properties of the Societies movable or immovable shall vest in the Board of Trustees who shall have absolute discretion to hold and administer the same in any manner they may deem fit for the promotion of the objects of the Society.
- 20) The Board shall have power to acquire and hold properties by purchase or lease or otherwise to lease, mortgage, sell exchange and hypothecate the properties of the society and to borrow moneys on the security of any of the properties of the Society.
- 21) The President shall have power to appoint one or more Secretaries and a Treasurer and may, if necessary, appoint Assistant Secretaries and other staff of such terms as they think fit. The Board may appoint the same person as Secretary as well as the Treasurer. -The first Secretary and Treasurer shall be Miss V. Aruna and V. Narayanan respectively.
- 22) The Board may transact business whenever necessary by circulation of papers among the members of the Board.
- 23) There shall be a separate committee of the Management, if necessary, appointed by the President for each branch of its service activities under the Kendram to be incharge of the day-today administration of the affairs, of the respective institutions.
- 24) The Board shall have power to make bylaws not in consistent with the Memorandum of Association.
- 25) a. The Board shall invest funds of the Society in the name of the Society in any/Scheduled Bank/Nationalised Banks/State Bank of India or Banks in India or in Government Securities and Secretary and Treasurer shall maintain correct accounts in respect thereof. The board can borrow funds from the Banks for improvement of the Kendram and running it. It will authorise the President and/or Secretary and Treasurer to execute necessary documents.
- 25) b) The board shall have power to authorise one or more of the trustees or the Secretary of the Treasurer either individually or jointly to operate on the funds of the Society.
- 26) a. The President shall arrange for the day-today transactions of the Society and its various activities by appointing necessary staff. He is authorised/incur /to

the necessary expenditure.

26. b. The President shall have power to appoint staff required to run the Kendram and its branch services. The service conditions and scale of pay will be framed/ revised by the Board of Trustees.
27. The accounts of the Society shall be audited annually by a Chartered Accountant appointed by the Board on such terms as they think fit.
28. The object of the Kendra is charitable and not to make profits. Nevertheless, if any surplus arises in carrying out the objects, the same shall be added to the capital fund of the Kendra and the surplus will not be claimable between the members of the Kendra.
29. a. There shall be meeting of the Board of Trustees ordinarily once in every three months. It shall, however, be open to the President to convene meeting of the Board at any time as he considers necessary.  
b. Seven clear days notice in writing shall be given of meetings of the Board. Such notices shall be issued by the Secretary by ordinary post to the last known address of the Trustees.
- 30) The quorum for meeting of the Board shall be four.
- ~~31)~~ At the meetings of the Board, the decision of the majority shall prevail and where the votes are equal the President or Chairman shall have casting vote.
- 31) The President shall preside the Board's meetings. In his absence, his nominee will conduct the proceedings of the meeting.
- 32) At the meetings of the Board, the decision of the majority shall prevail and where the votes are equal the President or Chairman shall have casting vote.
- 33) Accurate minutes of Proceedings of all meetings shall be placed before the next meeting for confirmation.
- 34) The general body meeting of the Kendram shall be held once in the month of July of every year. A list of membership to be sent to the Registrar, Palayamkottai within 14 days after the Annual General body Meeting.
- 35) On a written application by any member of the Society, the copies of by-laws the Receipt and Expenditure account and Balance Sheet shall be supplied to him on payment of fee of Re.1/- for each copy of the document required.
- 36) The extraordinary General Body Meeting of the Kendram will be convened at the requisition not less than 3 members of the Kendram in writing calling for such meetings. The President shall convene such meetings within 30 days from receipt of notice and he will preside over such meetings.
- 37) The Secretary or in his absence authorised by the President shall prepare and file with the Registrar such records, annual or other statements which are specified in the Act and Rules.

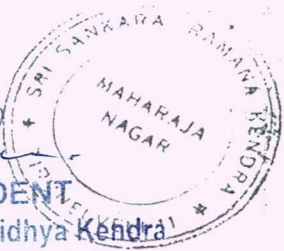
